Darts-ip collects information from over 140+ countries around the world, encompassing 3,800+ courts and offering access to documentation from over 5 million cases through the Darts-ip platform.

The purpose of this document is to provide a consolidated summary of the scope of collection activity. This summary is comprehensive, though nonexhaustive, in its scope, giving an overview of the collection status of IP litigation and prosecution information in each country. The countries in this document are grouped by legal perspective – with the aim to provide an overview of collection declining from the same legal structures.

Within the legal perspective, countries are ordered alphabetically.

For each individual country, there is a breakdown of the IP domains (Trademark, Patent, Copyright, Domain Names, Design and Model, Unfair Competition) we gather data from, as well as a highlighted section of the key courts for each jurisdiction.
